6.3 Tax Zones

These are the default Tax Zones (Areas) in Canada.

Unless tax rates are legally changed, nothing should be edited.

Tax Zones are separated into different groupings of Provinces all having the same tax rates. If your customers live within Canada, applicable taxes will be calculated to the product total according to the area of which they live in.

If your customers live outside of Canada, by default, no taxes will be charged.

6.4 Tax Classes

There are three tax classes.

The first class (GST/HST/PST) applies to **products only**.

The second class (GST Shipping Class) applies only to the Shipping Fee.

If your customers live within Canada, by selecting these classes, applicable taxes will be calculated.

6.5 Tax Rates

Refers to Provincial Tax Rates

Unless tax rates are legally changed, nothing should be edited.

Shipping fees will include a 15% GST if products are shipped to Ontario, New Brunswick, Nova Scotia and Newfoundland.

Shipping fees will include a 7% GST if products are shipped elsewhere in Canada.

The invoice calculation will be based on your own calculation settings for the tax rates shown in this section.
